OR Bidder who chooses to submit their bid electronically, download the bidding documents for e-submission from PPMO's Web Site <u>www.bolpatra.gov.np</u>. Bidders submitting their bid electronically should deposit the cost(as specified above) of bidding document in the Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- 4. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified above. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit accountNo. 4180303003001(Dharauti) of Office of the Belauri Municipality ,Kanchanpur at RastriyaBanijya Bank Mahendranagar and submit the receipt of the deposited amount of cash or scanned copy of such receipt in pdf format in case of e-bid should be submitted along with the bid.
- 5. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 6. Any intimidation, threats collusion during bidding process shall be punishable by law.
- 7. The purchaser reserves all right to accept or reject, wholly or partially any or all the sealed quotation without assigning any reason, whatsoever.
