The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on 2078/02/11 at the office of Belauri municipality Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum of below mentioned amounts, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days).
- 7. If the last date of depositing cost of bidding documents falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
