1. **Belauri Municipality** has allocated funds and received grant from Government of Nepal towards the cost of **Construction of Ring Road Section in Ward No.5-4-3-1 & 2 in Belauri Municipality** and intends to apply part of the funds to cover eligible payments under the Contract for Contract No: **BELMUN/NCB/W/079/080-09** Bidding is open to all eligible as per Section V of bidding document.
2. **Belauri Municipality** invites electronic bids from eligible bidders for the **Construction of Ring Road Section in Ward No.5-4-3-1 & 2 in Belauri Municipality** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs . 9,61,00,000**
 - Minimum Work experience of similar size and nature: **NRs 5,77,00,000** Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Pre-bid meeting shall be held at **Belauri Municipality Kanchanpur** at **12th April 2023, 12:00**.
6. Electronic bids must be submitted to the office **Belauri Municipality Kanchanpur** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **13:00 hrs on 23th April 2023** Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 23th April 2023** at the office of **Belauri Municipality, Kanchanpur**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a minimum of **Rs.23,73,000** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
