4. Pre-bid meeting shall be held at **Belaury Municipality office** at **11.00 am on 2076/08/24**
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before **12.00 on 2076/09/04**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2076/09/04** at the office of **Belaury Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum of **(2 to 3 % of estimated amount inclusive VAT)**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **120 days**).
7. If the last date of depositing cost of bidding documents falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
